# 6. <u>INTRODUCTION TO THE BASIN MANAGEMENT OBJECTIVE THRESHOLD</u> AND RECHARGE MAPPING PROJECT

Jim Blanke with RMC Inc. provided an overview of the Authority's Basin Management Objective Threshold Development and Recharge Mapping Project. See PowerPoint link attached to the 7/9/2014 materials on http://www.scgah2o.org/.

Mr. Ocenosak asked if there would be ongoing management once the model was put together and whether or not the model required validation. Mr. Blanke replied that the existing model would be used with a small update to 2030 conditions. There would be no recalibration or major update required.

Mr. Ocenosak asked if the model run would establish what the minimum and maximum threshold elevations would be set at or if it was to be determined by the Authority? Mr. Blanke replied that those would ultimately be management decisions.

Mr. Blanke stated that if there was a desire to re-word how the bandwidth would be developed or established, it would be best to do it earlier in the process.

## 7. EXECUTIVE DIRECTOR'S REPORT

- a) SCGA Letters of Appointment Mr. Eck announced that appointments to the Authority Board were necessary for the Cities of Sacramento, Folsom, Rancho Cordova, Elk Grove, in addition to the Golden State Water Company and the Florin Resource Conservation District.
- b) Legislation Mr. Eck stated that groundwater management was a high priority for both the Administration and the Legislature this year. The Governor's May revised budget contained funding and positions for both the SWRCB and DWR to engage in groundwater management activities. The legislation of primary interest was SB 1168, Pavley and AB 1739, Dickinson. RWA had sent letters (June 19, 2014) to both Senator Pavley and Assembly Member Dickinson articulating support for and concerns over aspects of these bills as it relates to the region.

## 8. <u>DIRECTORS' COMMENTS</u>

Mr. Ocenosak announced that SRCSD was starting an extensive outreach effort for south County agriculture and habitat lands relative to their recycled water program. SRCSD was looking to outreach to farmers and others who would potentially be on the receiving end of recycled water. The effort would be taking place over the next couple of months. SRCSD was also aiming to get an N.O.P. environmental document together by the end of this year with a goal get public input.

Mr. Williams commented that SCWA was awaiting State recommendations for impending emergency drought requirements.

Mr. Bettis said he attended a SACOG meeting where they had the city managers and that they'd be more involved due to the drought and if any of you were going to represent.

## **BACKGROUND:**

On August 29, 2014 the state legislature approved SB 1168, SB 1319, and AB 1739. In broad terms the various bills contain the following criteria.

- Sustainable Groundwater Management (SB 1168)
- Basin Boundaries (SB 1168)
- Establishing Groundwater Sustainability Agencies (AB 1168)
- Powers and Authorities (SB 1168)(AB 1739)
- Groundwater Sustainability Plans (SB 1168)
- Probationary Basin Status (SB 1319)
- Technical Assistance (AB 1739)
- Financial Authority (AB 1739)
- Groundwater Sustainability Agency Enforcement Powers (AB 1739)
- State Evaluation and Assessment (AB 1739)
- State Intervention

Other activities addressed include:

- Actions required by land use authorities (AB 1739)
- Actions required by water purveyors (AB 1739)

This legislation still requires the governor's signature. Staff will be reviewing the legislation in conjunction with SGA and will report back on necessary actions and timelines.
